As the owner of a Branch Office, you'll be at the nucleus of entrepreneurialism in your community by increasing financial literacy and access to capital. You manage the P&L and keep 100% of the profits.

BRANCH OFFICE COMPENSATION MODEL

Branch Offices operate independent business units through a licensure* arrangement (not a restrictive franchise). The compensation model is designed to generate a minimum of \$100,000 per month/\$1.2M annually to the Branch Office but can be considerably more based upon your leadership and implementation.

Compensation plan specifics:

- **Upfront income:** Branch Offices determine the processing fee generated from each Grant participant.
 - Most Branch Offices will charge a \$999.99 processing fee per Grant participant.
- **Passive income:** Branch Offices earn 5% of each Grant participant's capital raise.
 - The minimum Grant participant capital raise is \$100,000 generating at least another \$5k to the Branch Office.
 - However, with a \$1M capital raise, the Branch earns an extra \$50,000 per Grant participant.
